INR 8billion Bank Loan Upgraded to 'IND BBB', Outlook Stable from 'IND BBB-', Outlook Stable

INR 2.5billion Additional Nonconvertible debentures(NCD): 'IND BBB', Outlook Stable

Of which, maximum unsecured Nonconvertible debenture would be INR0.3billion

INR12.54billion Nonconvertible debenture Upgraded to 'IND BBB', Outlook Stable from 'IND BBB-', Outlook Stable

(Total utilized limit of NCD stands at INR10.4billion)


